#### Initial Educational Consultation – \$350

- In-person or virtual meeting up to two hours in length with parents/guardians. The student may be included in the meeting, but advocates may not participate.
- Includes review of medical history (including neuropsychological evaluation) as well as school reports, plans, and Individualized Educational Plan (IEP).
- Includes provision of educational impressions, preliminary recommendations, and review of next steps.

#### School IEP/Team Meeting - \$350

- Offered after Initial Educational Consultation (+\$350)
- Virtual or in-person meeting with school team to review IEP, placements, or other concerns.
- Includes record review, participation in one-hour meeting, and related documentation.

#### Comprehensive Educational Assessment – \$950

- Offered after Initial Educational Consultation (+\$350)
- Diagnostic evaluation of reading, writing and math performances, utilizing more than one assessment in each area.
- Includes error analysis, recommendation for teaching methodology, and 30-minute parent/guardian feedback session to review results.

### Psychoeducational Evaluation – \$1200

- Offered after Initial Educational Consultation (+\$350)
- Includes record review and evaluation of intellectual ability, perceptual motor skills, language, attention, and executive functioning, in addition to the above-described evaluation of academics (Comprehensive Educational Assessment).

## Targeted School Observation – \$1200 + travel time (\$50 per 30 min.)

- Offered after Initial Educational Consultation (+\$350)
- Up to two hours of observation time, with extended time billed at \$200 per hour.
- Includes observation report and 30-minute parent/guardian feedback session to review findings.

### Additional Consultation Time – \$50 per 15 min.

• For all services, additional consultation time will be billed at a rate of \$50 per 15 minutes.
