

Nuts and Bolts of Partial Retirement Benefit Considerations in 2024

For Monthly Paid Mass General Faculty

Benefits Eligibility for Monthly Paid MGH, MGPO and MEA Physicians and Researchers

Defined as **50% of full-time equivalent FTE**, or 20 standard hours every week. This includes clinical, research, teaching and administration time.

At this effort, you are considered <u>full-time</u> for purposes of benefits eligibility and the cost of medical insurance. Disregard references to part-time.



Your FTE determines benefit eligibility

If you work 50% FTE, or more, (or 20 standard hours or more every week) then you are "BENEFIT ELIGIBLE"

If you work less than 50% of full time (FTE) (or less than 20 standard hours every week) then you are "NOT BENEFIT ELIGIBLE"



The Change in your Work Schedule

If you work 50% of full time, or more, then you are *Benefit Eligible*

Reduction in your Base Annual Salary:

Affects certain benefits, such as:

- Life Insurance
- Long Term Disability
- Retirement Benefits

Decisions to make:

Pay yourself a paycheck?

- Personal Savings
- Social Security, IRAs, Retirement Plan
- Other Investments

If you work <u>less than 50%</u> of full time then you are <u>Not Benefit Eligible</u>

- Retirement Health Insurance Coverage
 - If 65+ then Medicare, Medigap
 - If under 65 then COBRA (high premium)
- Retirement Income Plans
 - Social Security, IRAs, Retirement Plans
